

Education Project 2018-2020 Prospectus

This project aims to expand influence and reach by promoting increased use of ASCIA resources by health professionals, to improve patient care. Our main focus will be in the following clinical areas:

- Anaphylaxis and allergies to foods, drugs and insects
- Respiratory allergy allergic rhinitis (hay fever) and asthma
- Primary immunodeficiency and other immune diseases

BACKGROUND

In 2017 ASCIA has undertaken a substantial review and updating of its website resources, including ASCIA's world leading e-training courses and action plans. ASCIA has also developed several new resources to meet needs that have been identified through feedback from health professionals and patients.

Whilst visits to the ASCIA website, uploading of ASCIA resources and registrations for ASCIA e-training courses have significantly increased, we believe that there is still potential to increase the use of ASCIA resources by health professionals, to improve patient care. It is therefore important that these new and updated ASCIA resources and their clinical applications are promoted to health professionals throughout Australia and New Zealand. It is also vital to obtain feedback, to enable ASCIA to continually evaluate and improve its resources.

The following policy will continue to apply to the ASCIA website and all ASCIA resources:

ASCIA resources are developed and peer reviewed by ASCIA members and based on expert opinion and the available published literature at the time of review. Information contained in ASCIA resources are not intended to replace medical advice and any questions regarding a medical diagnosis or treatment should be directed to a medical practitioner. Development of the content of ASCIA resources is not influenced by commercial organisations.

HOW WILL THIS BE ACHIEVED AND FUNDED?

The ASCIA Education Project 2018-2020 will require funding from annual unrestricted educational grants, to enable ASCIA to:

- Innovate
 - create new information as required and new "landing" ASCIA webpages to improve access
 - review, update and streamline existing online ASCIA resources
 - reconfigure and update ASCIA e-training courses to increase interactive learning
- Promote
 - develop electronic and printed collateral that includes key messages about ASCIA resources
 - use various communication channels, including e-newsletters, collaborative organisations, social media, health professional media networks and face to face distribution of collateral
- Sustain
 - re-accredit ASCIA e-training courses as required
 - retain free accessibility of ASCIA resources, including e-training courses
 - encourage and invite feedback to enable ASCIA resource evaluation and improvement
