ASCIA President's Report - Dr William Smith

Welcome to the ASCIA 2018 Annual General Meeting. As we approach the 30th anniversary for ASCIA I would like to take this opportunity to highlight some of the recent significant achievements of ASCIA.

ASCIA ANNUAL CONFERENCES

On behalf of ASCIA, congratulations and thank you to the co-chairs of the 29th ASCIA Annual Conference (A/Prof Katrina Randall and Dr Elizabeth da Silva, their organising committee, the CFAR Symposium team (led by Prof Katie Allen), the inaugural Dietitians Course team (led by Ingrid Roche), speakers and chairs.

We are extremely grateful to these and other ASCIA members who volunteer their time and expertise.

ASCIA annual conferences provide an international standard of continuing professional development and an opportunity to interact with colleagues working in these areas. ASCIA conferences are therefore a highlight of the year for ASCIA members and other health professionals wo work in allergy and clinical immunology.

OTHER ASCIA MEETINGS

As well as the ASCIA 2018 Conference, ASCIA has hosted other meetings in 2018 which have provided opportunities for collaborations and continuing professional development. These include:

- ASCIA TAPID face to face meeting (May 2018) and monthly teleconferences Thank you to Theresa Cole and Jo Smart
- ASCIA SCIg (subcutaneous immunoglobulin) resources workshop (May 2018) Thank you to this
 group who have developed extremely useful resources over the past two years.
- ASCIA WA Immunology Day (June 2018) Thank you to Prof Michaela Lucas, Dr Chris Bundell and Monica Kemp.

ASCIA WEBSITE UPDATE

It is a pleasure to announce that after several months of work, the ASCIA website www.allergy.org.au has been redesigned to be more user and device friendly. The ASCIA website is a trusted and extremely popular source of information about allergy and other immune diseases, with more than 1.6 million annual visits. We have therefore not changed the content. However, the design has been substantially updated and some URLs (uniform resource locators) have been streamlined, to improve access. Thank you to our webmasters and Jill Smith for their work on this.

ASCIA ETRAINING COURSES

ASCIA currently hosts a total of 18 e-training courses, comprising:

- 6 ASCIA anaphylaxis e-training courses for non-health professionals; and
- 12 ASCIA e-training courses for health professionals.

With over 88,000 registrations for ASCIA training courses in the past year (2017-2018) it is important that ASCIA regularly reviews, updates, accredits and manages the courses to be sustainable. All of this work is time consuming and I thank ASCIA staff, webmasters for their work, as well as the ASCIA committee chairs and members who volunteer their time and expertise to the content of ASCIA courses.

AIFA

In 2013 ASCIA established AIFA, the Allergy and Immunology Foundation of Australasia, to fund allergy and immunology research and raise awareness. To date AIFA has funded \$160,000 in grants and the latest grant recipient will be awarded their grant at the ASCIA 2018 Conference Closing function on Friday 7th September.

Donations to AIFA increased by 45% in 2017-2108 and more than quadrupled in 2016-2017, despite a challenging fundraising environment. As a result of increased donations from generous ASCIA members and other donors, we intend to expand AIFA grants, with at least \$100,000 of grants to be awarded in 2018-2019.

Thank you to Melanie Wong and the AIFA grant selection panel members who volunteer their time to AIFA, Michelle Haskard for coordinating the grant selection process and Christa Bayer for her fundraising achievements over the past two years. We are intending to utilise Christa's skills to further develop ASCIA sponsorship, as well as fundraising for AIFA over the next year.

NATIONAL ALLERGY STRATEGY

The National Allergy Strategy (NAS) continues to be the most significant recent collaboration for ASCIA in partnership with Allergy & Anaphylaxis Australia, working together with other stakeholders since 2014.

The following NAS projects that were completed in 2017 have provided important new resources:

- 250K website for young people with severe allergies <u>www.250K.org.au</u>
- All about Allergens food allergy training for food service www.foodallergytraining.org,au

Work will continue on these projects as a result of further government funding.

On Monday 27 August 2018 the NAS food allergy prevention project, *Nip Allergies in the Bub* was launched in Western Australia where it will be piloted for a year, before it is launched throughout Australia. This project is the first in the world to promote feeding children the common allergy causing foods by one year of age, to help prevent food allergy from developing. The website www.preventallergies.org.au contains information for parents, carers and health professionals.

It is important to note that the websites and other resources developed for NAS projects can also be utilised in New Zealand.

I had the pleasure and privilege to attend the NAS event at Parliament House Canberra on Thursday 16 August 2018, along with Dr Brynn Wainstein. This event was a great achievement in advocacy for all Australians living with allergic disease, with the government announcing 5 years of funding for NAS initiatives.

The acknowledgment of allergic disease and its impact on so many Australians was evident by the bipartisan support from Greg Hunt MP, Ken Wyatt MP, Senator Richard Di Natale and Catherine King MP, who all spoke at the event. Thank you to A/Prof Richard Loh, Maria Said, Barry Hickey and Jaclyn Jauhiainen, who also spoke at the event, to Sandra Vale for coordinating the NAS, Rikki Dunstall for providing support, and all the supporters who attended the event and/or have contributed to the outstanding success of the NAS.

I also take this opportunity to congratulate A/Prof Richard Loh, Maria Said and Sandra Vale for their work on implementing the NAS, and their continued advocacy to government for support.

OTHER COLLABORATIONS

We also value the other collaborations that involve ASCIA, including new and ongoing relationships with:

- Other professional organisations, including:
 - ASI (Australasian Society for Immunology)
 - DAA (Dietitians Association of Australia) in 2018 we have worked together to develop the ASCIA-DAA Dietitians Course, which will be held for the first time in conjunction with the ASCIA 2018 Conference.
- Research groups, including AusPollen and CFAR (Centre for Food & Allergy Research)
- TAPID (Transplantation and PID) project.

SUBMISSIONS

Over the past year ASCIA has made several submissions to government and other organisations, including:

1. ABS (Australian Bureau of Statistics) Census consultation

 ASCIA made a submission to request the inclusion of a simple question that aims to capture data on allergic diseases and other immune system disorders in Australia in the 2021 Census – submitted 29 June 2018.

2. Australian Breastfeeding Strategy consultation

 ASCIA made a submission to request the inclusion of information from the ASCIA Guidelines for infant feeding and allergy prevention in Section 1 of the Australian Breastfeeding Strategy – submitted 18 June 2018.

3. ACF (Australian Consensus Framework)

ASCIA provided feedback to the development of the ACF which was recently launched.

4. IHPA (Independent Hospital Pricing Authority)

 ASCIA made a submission in response to the IHPA public consultation paper regarding the Australian Non-Admitted Care Classification (ANACC) – to request inclusion of relevant clinical immunology and allergy services, particularly for immunoglobulin replacement therapy for immunodeficiency, allergen challenges and allergen immunotherapy – submitted 19 April 2018.

5. MBS Review of Skin Testing

- In July 2017 ASCIA wrote a detailed letter in response to the proposed changes to allergy skin testing as a result of the MBS review process.
- In July 2018 ASCIA wrote another letter requesting clarification of changes after receiving incorrect information.
- The MBS will confirm changes to allergy skin testing as a result of the MBS review process and this will be communicated to ASCIA members.

6. NSW State Scope of Clinical Practice Unit - Paediatric Scope of Clinical Practice

• Feedback from ASCIA was sent on 23 February 2018.

7. PBAC (Pharmaceutical Benefits Advisory Committee)

- ASCIA submitted a letter supporting the Adrenaject application on 7 February 2018
- ASCIA submitted a letter in support of Pharmaceutical Benefits Scheme (PBS) listing of Dupixent® (Dupilumab) injections for severe eczema in adults on 6 June 2018.

8. RCPA - Request for authorised prescriber endorsement letter

- Letter was received on 31 January 2018 and circulated to ASCIA Full (Ordinary) members who are fellows of the RCPA.
- An updated letter was circulated on 23 May 2018.

9. TGA (Therapeutic Goods Administration)

- ASCIA made a submission regarding mandatory reporting of medicines shortages consultation to request inclusion of relevant allergy and immunology treatments submitted 30 April 2018.
- ASCIA also responded to the TGA Latex allergy labelling in medicines consultation on 26
 February 2018. The updated document was been published on the TGA website in May 2018:

- Managing and prioritising updates and new projects whilst maintaining current staffing levels and not overloading ASCIA members who volunteer their time and expertise.

- The tables above compare the past 4 financial years, which have been relatively strong for ASCIA.
- ASCIA has made a small surplus in 2017-2018 (table 1).
- The figures in tables 1-4 include \$500,000 of National Allergy Strategy funding. A separate budget and report for this funding for the federal government funded projects is submitted upon completion of the projects. These funds are allocated and spent each year, so the surplus is not due to this funding.
- ASCIA's risk management plan includes having retained earnings of ~\$1.5 million in reserve, to allow for income fluctuations and fixed office costs. This goal has now been achieved for the last 7 years (table 2).
- ASCIA uses accrual based accounting which shows a more accurate financial position of the organisation.
 This means that all income for the ASCIA 2018 conference and the National Allergy Strategy projects for
 2018-2019 are assigned to the Balance Sheet as income in advance in Liabilities. Prepayments for the
 ASCIA 2018 conference are assigned to the Balance Sheet as prepayments in Assets (table 2).
- The ASCIA Annual Conference income is the most important and consistent source of funding (table 3).
 Exhibition and sponsorship income continues to increase each year. We are keeping records that compares income and expenses for each conference, which will assist in negotiating rates for future conferences and with budget planning.
- Donations to AIFA increased by 45% in 2017-2108 and more than quadrupled in 2016-2017, despite a challenging environment. As a result of increased donations, we intend to expand the number of grants provided in 2018-2019.

Incoming ASCIA President's Message - Dr Brynn Wainstein

I am extremely honoured and proud to lead ASCIA into its 30th year. ASCIA is in a fortunate position today due to the leadership of Presidents who have served before me, many who are at this conference, the active participation of ASCIA members and the support and guidance from ASCIA staff.

Since 1990 ASCIA has grown into a world leading, innovative and active professional society with strong and progressive leadership.

From 1990 to 2000, ASCIA built a strong foundation for the future, including:

- Hosting of ASCIA Annual Scientific Meetings.
- Successful bidding and hosting of the World Allergy Congress in 2000.
- Development of a new Strategic Plan in 1999-2000, with a focus on web based education.

From 2000 to 2010 ASCIA established an education focus, including:

- Implementation of a new **Strategic Plan** with an emphasis on open access web based educational resources for patients and health professionals.
- Development of the first versions of **ASCIA Action Plans for Anaphylaxis** in 2003, that are now recognised as world leading resources.
- Development of the first version of ASCIA infant feeding advice in 2008.
- Management of its own Annual Scientific Meetings since 2006 (now called Annual Conferences).
- Development of the first free of charge **ASCIA anaphylaxis e-training courses** (for schools and childcare services) in 2010.

From 2010 to 2017 ASCIA significantly expanded its education, training, advocacy and strategic planning, including:

- Development of a wide range of free of charge **ASCIA e-training courses** for health professionals, schools, childcare and the public.
- New and updated ASCIA action plans, guidelines and other resources that promote high standards, available open access from ASCIA website.
- Collaborations to improve patient care, including TAPID (transplantation and PID) and AusPollen projects.
- Establishment of AIFA (Allergy and Immunology Foundation of Australasia) in 2013, to fund research and raise awareness.
- Management of ASCIA Annual Conferences since 2014 (replacing the ASCIA Annual Scientific Meetings).
- Development of new ASCIA guidelines for infant feeding and allergy prevention in 2016.
- Comprehensive review and updating of ASCIA website information in 2017.
- Development and implementation of the first National Allergy Strategy for Australia, in partnership with Allergy & Anaphylaxis Australia and key stakeholders.
- 250K for young people will severe allergies was the 1st NAS project launched in 2017
- All About Allergens training for food service was the 2nd NAS project launched in 2017

In 2018-2020 the main priorities for ASCIA include:

- 1. **ASCIA Annual Conference** (2018-Canberra, 2019-Perth, 2020-Melbourne)
- 2. Promoting the redesigned ASCIA website
- 3. **ASCIA Education Project 2018-2020** which aims to expand influence and reach by promoting increased use of ASCIA resources by health professionals, to improve patient care.
- 4. **Expansion of AIFA research grant programs and AIFA awareness initiatives** to increase funding for allergy and immunology research and raise awareness.
- 5. **National Allergy Strategy (NAS) projects** ASCIA is involved in the NAS food allergy prevention project. ASCIA will also continue to promote 250K and All about Allergens
- 6. **Continued advocacy for patients with allergy and other immune diseases** through development of education resources, submissions and collaborations.

I would like to take this opportunity to thank Dr William Smith for his strong leadership as ASCIA President over the past 2 years, from 2016 to 2018. As outlined in the President's Report there have been significant developments over the past 2 years, with significant projects initiated and completed.
